virtue of the said Articles I give bequeath and dispose thereof as followeth that is to say **Impris** I give and bequeath unto my loving husband the said William Lovelock my Messuage or Tenement with the appurtenances being in Bow Lane in the Parish of St Mary Le Bow in London now in the possession of Goss Pauley or his Assignes And also my Messuage or Tenement with the appurtenances lyeing in St Johns in the Parish of St James Clarkenwell in the County of Middx now in the possession or occupation of Sr John Katharan or his Assignes to hold unto him or his Assignes for and dureing the terme of his natural life And I doe give unto my said Husband his Executors Testators and Assignes All my Messuages or Tenements with their and every of their appurtenances lyeing and being in

Shorditch in the Parish of St Leonard Shorditch in the said County of Middx for all such time and term of years as shall be to come and unexpired at the time of my decease **Item** I give unto my Granddaughter Elizabeth Grovers and her Husband five pounds apeece to buy them Mourning and I give unto my Grandchildren John Maddox Lovelock Maddox and Sarah Greatrix five pounds

apeece to buy them mourning **Item** I give unto my Grandson John Maddox the Annuity of fourteen pounds in the Exchequer purchased in the name of him the said John and the sum of four hundred pounds to be paid him at his Age of three and twenty years and my Will is that four pounds a year be paid him out of the profits thereof to find him in Cloaths and the rest of the

Interest or profits thereof until he shall attain the said age and be for his use and added to the said four hundred pounds and that his Mother shall not meddle with the same **Item** I give unto my Grandaughter Lovelock Maddox the sum of four hundred pounds of lawfull money of England with that her mother left her And an Annuity in the Exchequer purchased for ninety nine years to her and her heirs which said Legacys I will shall be paid her at her age of twenty one years or day of Marriage which shall first and next happen And in case she shall happen to dye before her said twenty one years or day of Marriage that then I will the same shall goo and be divided among my two Grandchildren John Maddox and Elizabeth Grovers share and share alike and that the interest of the said four hundred pounds and the Annuity from and immediately after my decease shall goo towards maintenance of the said Lovelock Maddox where and in such maner as my Executors shall think fit but not with her Couzen Grovers nor Mr Jackson And I doe further give unto the said Lovelock Maddox after the death of my said Husband my said house in Bow Lane with its appurtenances to hold unto the said Lovelock Maddox for and dureing the remaining terme then to come in the same to goo to Sarah Greatrix dyeth alsoe before the expiration of the said term then the same to go to Sarah Greatrix for and dureing all the remainder of the said term then to come in the same premisses if the said Lovelock Maddox shall soo long live and if she dyeth before the expiration of the said Sarah Greatrix dyeth alsoe before the expiration of the same to be shared and divided between my Grandchildren John Maddox and Elizabeth Grovers share and share alike for and dureing soo much of the time and term as shall be then to come and unexpired in the Lease whereby I hold the same And tis my .... And will that my Executors shall pay apply and dispose of the interest and profits of the said four hundred pounds and of the rent of the said house in Bow Lane after the decease of my sa

her my said Granddaughter **Item** I give and bequeath unto my Granddaughter Sarah Greatrix the sume of one hundred pounds of lawfull English money to be paid unto her at her age of twenty one years or day of Marriage which shall first happen and the house in St Johns after her Grandfather William Lovelocks decease and the Interest and profits that shall be made of the said one hundred pounds in the mean time shall goe and be applied for and towards her better maintenance and Educaton And I give unto her the Reversion of fourteen pounds per Annum in

the Exchequer after the decease of the said Lovelock Maddox and all my estate terme of years and interest thereon And I doe further will that her mother shall not have the management of the said Legacey or of any thing also intended for her the said Sarah by this my Will and if my said Grandson John Maddox shall departe this life before he attaine to the age of three and twenty years then I give the Legacey Estate and interest of him soo dying unto Elizabeth Grovers wife of Hugh Grovers for her use her Husband medling not with it And I give unto my Granddaughters

all my Cloaths both Linnen and Woollen to be equally parted between them **Item** I give unto my Sister Purslow five pounds to buy her mourning and to Madam Billers five pounds desireing

her to order my buryall and she and my Sister to look after the bringing up of the said Lovelock Maddox **Item** I give to my Sister Sarah Purslow my Gold Watch to Elizabeth Grovers my Diamond Ring and to Lovelock Maddox my necklace of Pearl And I doe hereby make ordaine institute and apointe the said John Billers and my Brother John Purslow Executors of this my

last Will and Testament and I give unto my said Executors five pounds apiece And Lastly if my said Husband William Lovelock shall goe about to hinder or disturb my said Grandchildren in receiving and enjoying what I have herein before given and intended for them respectively then and in such case I give the houses and everything else therein before given and bequeathed unto him for such estate and interest as is before lymitted unto him unto all my said Grandchildren before named And I leave my loving Husband William Lovelock Overseer of this my

will **In Witnesse** whereof I the said Elizabeth Lovelock have to this my Will and Testament confirmed in one skin of parchment sett my hand and seale this day and yeare first above written.

I add this as a codicil to my Will before sealing Item I leave fifty Guineas in Madm Billers hand for my burial and if that will not doe I will that my Husband shall pay what it takes to more out of the one hundred pounds he ows me.
